HINE's objective and service takes into consideration the design and development of the customer's products **throughout their whole life cycles** right from the start, as well as the setting up of production centres for large customers in the areas where they work.

In this way, relationships in the production process are strengthened further, by bringing help close to the customer with a **quick response time and flexibility in response to the changing demands of a globalized environment.** As a result, HINE has committed itself to a development strategy on a world level, which has involved a restructuring of the company in different business centres and a physical setting up on three continents.

The work environment of our products places a **high demand on HINE** as much in **development** as in the levels of **reliability** and **availability**, as is the case in these sectors: iron and steel metallurgy, machine tooling and energy.

Likewise, we support our commitment with the certification obtained years ago by the **ISO 9001** insuring ourselves to fulfil all the **requirements of the client**, including the regulations, committing ourselves with the continuous improvement.

In order to achieve the objectives of this policy, the Management of the HINE Group undertakes to:

- Make this policy known to all personnel who have any responsibility relative to the fulfilment of these requirements, as well as to third parts that act in HINE's representation.
- Set up plans and provide the necessary resources to fulfil this policy.
